Isolation is still required for individuals who test positive however, quarantine is NOT required for individuals who have been exposed and are symptom-free.

a.	Universal and correct wearing of masks;	Masks are required for staff for 10 days after exposure to COVID and through day 10 after isolating for a confirmed case. They are recommended for students if they are able to wear them.

C.	Handwashing and respiratory etiquette;	Appropriate and frequent handwashing will continue to be reinforced regardless of COVID status. Training for universal precautions will be provided to all staff and an emphasis on universal precautions will continue regardless of COVID status. Hand sanitizer, gloves and masks will continue to be available.

f.	Diagnostic and screening testing;	Symptomatic staff will test on their own and report results to the chief school administrator.
g.	Efforts to provide <u>vaccinations to</u> <u>school communities</u> ;	Vaccinations are not addressed in the school setting and are longer required for new staff.
h.	Appropriate accommodations for students with disabilities with respect to health and safety policies; and	The School at McGuire Memorial – Beaver County is a special education facility. Accommodations for our students have been considered and incorporated into all COVID policies and procedures.
i.	Coordination with state and local health officials.	Schools only need to work with state/local health officials during an outbreak.
